- Filled out and signed Pakistan business visa application form.** The form is enclosed.
- Original passport.** Passport must have at least 6 months remaining validity and have at least 1 visa page.
- 2 Photographs.** Standard passport photographs 2 x 2 inches on white background.
- Payment.** Credit Card Authorization form, Certified Check, or Money Order payable to VisaHQ.ca.
- Return mailer.** Prepaid self-addressed return label or payment for FedEx.

- Business Letter.** A business letter from either the sending company in Canada or sponsoring company in Pakistan, on their letterhead stationary, addressed to The Embassy of Pakistan, and signed by a senior manager (an equivalent to Vice-President or above), briefly introducing the applicant (please specify employment status/position held in the company by applicant) and clearly stating the precise nature of the business to be conducted by applicant. If requesting a multiple entry visa, the letter should specifically request the multiple entry visa and explain why the applicant will be traveling to Pakistan so often.

 - Employment Letter.** Letter from your employer in Canada (format suggested confirming that you are currently employed by the company and for how long. If you own the business, please add a copy of your business's official registration. The letter must be original, written in or translated into Spanish, on company letter-head paper, signed by the person in charge. Those documents must be certified by a Notary Public who is registered at this Consulate General (please call us to find out contact details). If you are a student at a University, original letter from your University in Canada confirming that you are currently a student there).
